## Power Line Safety Considerations—Mark Vallo of First Energy September 30, 2008 Dimitri's Dinner Meeting



One of the more prominent headlines in the news this summer was about a ham radio father-son team who were electrocuted while trying to erect an antenna in their back yard. It seems that they lost control of the mast they were erecting and it came in contact with a 12.5 KV distribution feeder which ran along the top of their power poles in the yard. Accidents like this are often rooted in a lack of knowledge and respect for the type of power lines that can be found in the typical residential neighborhood. Mark Vallo of First Energy will present a pro-

gram on power line safety as it applies to our Amateur Radio installations and operations. This program is a "must see" for any Amateur who has an outdoor antenna where there are overhead power lines.

- 2) You get to meet new people (and probably make a few new friends), with whom you are sharing a common goal in these events. Having a common goal makes this much easier. And having more friends is better than having fewer friends.
- 3) "Giving back to the community" isn't just a trite phrase, it's the right thing to do.
- 4) These events, although they seem like work before you do it, are really a lot of fun.
- 5) These events are really practice for us. Practice in directed net operations, which is absolutely critical during times of REAL need.

With a membership of about 300 hams, we as an organization should not have to go begging for volunteers. Someone once told me that "to whom much is given, much will be expected". In our case, the "much that is given" is the wide chunks of radio spectrum to which we have access. In return, the "much" that is expected, really isn't all that much. Next year, when there's an event coming up, come on out and help. It ends up being a lot of fun, you just might learn something, you'll probably enjoy yourself more than you thought you would, and it's the right thing to do.

## Ohio State Parks On-the-Air 2008 Report

The first event of LEARA's "busy weekend" was the first Ohio State Parks on the Air contest. Sponsored by the Portage County Amateur Radio Service (PCARS), it was held on Saturday, September 6. The purpose of this event was to promote Amateur Radio and the Ohio State Parks. Because people enjoyed Field Day so much, we decided to make this like a "mini Field Day".

The rain stopped about an hour before we began setup. We planned to start at 9AM, but actually ended up getting going at more like 9:30. Gary - WA8TJL commented that he drove through rain on the way to the contest site from his home in the

eastern suburbs. Our site was the area of Cleveland Lakefront State Park called "Upper Edgewater". The funny part about this was that the LEARA trustee who absolutely insisted we use Edgewater instead of our usual Field Day site was nowhere to be found on Saturday. The tent was setup, and the antennas were hung low in the trees in plenty of time for the beginning of the event, which started at 12:00 noon. As the day progressed, the sky cleared, and that glowing orb in the sky (called the Sun) came out making for an absolutely gorgeous day. We saw sailboats on the lake, and a couple of guys parasailing, which was quite an interesting sight.

A number of club members stopped by, including Darren K8DMT, and John N8ABD. Several non-ham visitors stopped by to see what we were doing. One of the Park Rangers was even a ham, and he visited us several times throughout the day (although I don't remember his call sign). Ron, N8MPF stopped by and guest operated for a while, making an impressive string of contacts on 40 meters SSB, despite conditions that weren't all that great. The power line noise level in that part of the park runs a constant S-8 on the HF bands, so it's a good thing we don't operate Field Day from that location. And if we do this again next year, we'll probably use our Field Day site for its lower noise level.

When it was all said and done, we had 94 SSB contacts and 9 CW contacts in the log, and we worked stations in 19 different Ohio State Parks. This made our total score 1,957 points. It seemed like there were very few stations operating CW for this event, probably because there was no extra scoring for CW contacts like there is for Field Day. How did we rank? I guess we'll find out once everyone submits their log sheets, but I think we did pretty well. Everyone had fun, some people learned some new things, so it was a worthwhile event. It remains to be seen if this will become an annual event. I, for one, hope it does. -AR-

## 2008 River Run Report

Usually, just after Labor Day each year, a group of hams gathers in the before dawn gloom in an empty, darkened parking lot in suburbia. HT's at the ready, batteries fully charged, they huddle around the trunk of a parked car awaiting maps and assignments. This is how the annual Cleveland Clinic Sports Health River Run begins for a group of LEARA members each year. And on Sunday, September 7th, a group of 8 LEARA members proudly carried on the tradition, by gathering in the K-Mart parking lot at Bagley and Engle Road in Middleburg Heights just before sunrise for the 2008 version of River Run.

River Run is a half marathon and inline skate race through the scenic Rocky River Reservation of the Cleveland Metroparks, beginning at Wallace Lake in Berea, and ending 13.1 miles later near the Memorial Ball Fields in Rocky River, just south of the intersection of Hilliard and Wooster Roads. As usual, the inline skaters finished in about half an hour, for an average course speed of about 26MPH. The rest of the participants, except one, finished the event without incident. That one unlucky soul only had to be treated for a case of "road rash". After the event, some of the crew gathered near the finish line for a post-race snack. This year Geppetto's provided the pizza, and Panera Bread provided the bagels.



4. The membership chair, W8AZO reported that the club has 240 paid up members.
5. Further discussion regarding a comprehensive plan for LEARA's goals, that had been initiated by K2RJ at the July Trustee's meeting, was tabled due to his absence.
6. N8YNR reported the progress on fundraising projects, such as selling coffee cups or T-shirts with the LEARA logo. They are still working on improving the resolution of the LEARA logo for transfer to these objects. KC8GHX is helping to do this.
7. N8AUC reported on the status of the IRLP installation. After a thorough technical discussion it was felt that one more visit to the 146.88 site is necessary to resolve hardware issues. N8AUC and WB8APD agreed to go up there next Saturday, 20 September 2008, at 0900. They hope to be joined by N8YNR and WD8JMM. After that work is completed, software adjustments can be made remotely.
8. The technical committee report consisted of a statement by N8AUC that the 146.76 west input was not working. N8NAP thought the link to the hill might be down. But, after further discussion, it was felt that user(s) simply were not transmitting with the mandatory PL to bring up the remote receiver.
8. Marv, W8AZO reported on the status of the 146.76 repeater site relocation. Tri-C has refused to allow the use of their rooftops. W8AZO had also written to the Beachwood mayor for permission to use one of their facilities

but no response was received. KC8FOC offered his QTH in Warrensville Heights as a temporary home for the repeater in the event we are ordered off the roof of its present location. Other potential sites in the immediate area were mentioned and will be pursued.

9. The 444.40 repeater will be moved to N8YNR's QTH when the club is ordered to remove all the equipment from its present location on the hill, if not sooner. Jeff suggested that we begin removing what we can as soon as possible, as this could be a complicated procedure without the use of the building elevators.
10. As usual, LEARA will participate in the Cleveland Hamfest by setting up and manning a table. The Hamfest will be held on Sunday, 28 September 2008. A signup sheet was passed around.
11. The elections committee report was given by KA8BZB. He stated that there will be 4 incumbents (N8AUC, K2RJ, KC8FOC and K8EHP) plus two nominees (K8JTK and KD8ACO). Tom also stated that the elections committee should now be dissolved which lead to a lively discussion and a review of the bylaws. Biographies of those running will be sent to the members via email and published in the October Newsletter. This will reduce the number of pages mailed to the members with the ballots, saving postage. W8AZO, WD8JMM and KA8BZB will prepare and mail the ballots.

## NEW BUSINESS:

N8XDO will start working on the menu for the November holiday dinner.

WA8TJL asked if LEARA wants to offer radio classes again. The turnout last year was poor. He said that we need to do a better job promoting the classes. WA8TJL moved and W2THU seconded a motion that LEARA provide an entry level class into amateur radio early in the first quarter of 2009. This motion passed unanimously. WA8TJL and N8XDO will organize the classes as before.

The meeting was adjourned at 1122.



# RF Safety Corner

After writing my last column I was amazed by the number of people who wrote to tell me that cell phones are dangerous, and they have proof! I was directed to one of a number of videos that were available on YouTube, showing kernels of popcorn on a table that popped when one to four cell phones around them were transmitting. "It's obvious," reasoned these correspondents, "that if a cell phone can generate enough heat to pop corn, then it can also fry your brain cells!"

If you haven't witnessed one of those videos, you should. Pretty scary stuff, isn't it? When I first saw one of these videos it gave me pause. It didn't seem possible but there it was on the screen. These videos are copies or remakes of a professionally produced version from Cardo Systems, a manufacturer of Bluetooth remote headsets. Popping corn with a cell phone is clearly a hoax. Similar hoaxes include hard boiling an egg with a cell phone. Take a look to see how it is done (needless to say, every ham should immediately realize how dangerous this trick could be to perform).

Just as radio amateurs must prevent their stations from exposing people to unsafe levels of RF, cell phones are extensively tested to confirm that exposure to users will be under the Maximum Permissible Exposure (MPE). These thresholds are far below the levels of energy absorption that can raise the temperature of tissue noticeably -- really far below what it would take to pop a kernel of corn. If you're interested in experimenting, place a small container of water between the antennas of two or more operating cell phones and try to measure a change in temperature.

What about Cardo Systems? They claim that the hoax that they foisted on the public was meant to be humorous. That message got lost on YouTube and it had many people convinced that cell phones (and by extension, any RF source -- including Amateur Radio) are inherently dangerous. People continue to use their cell phones in spite of the danger, just as smokers continue to light up. It could be possible that Cardo's original message was

that these things are dangerous so you'd better buy a hands-free device, such as a Bluetooth headset.

After their hoax was revealed, Cardo Systems placed the following disclaimer on their Web site (they have since removed nearly all references to their popcorn hoax):

*The contents of these videos are fictitious and humorous optical illusions, designed for entertainment. Nothing in these videos is meant to imply that mobile phones can make popcorn and Cardo Systems, Inc. ("Cardo") specifically disclaims that these videos contain any portrayal of facts or comments about safety. Cardo disclaims any liability for the information in these videos.*

I have nothing against hands-free cell phone devices. I find it a little strange to see a Bluetooth appliance mounted in someone's ear, even when the phone is not in use; the comparison to Lieutenant Uhura in Star Trek is hard to avoid. There are lots of good reasons to use a hands-free device, including making the roads safer; however, avoiding brain-cell-frying is not one of them.

I also wonder about the wisdom of someone trying to sell an RF emitter that is mounted on the ear by frightening people about the use of another RF emitter. Clearly they targeted those who have no idea of how anything works.

Are there any limits to what can be said in order to sell a product? The Cardo Systems disclaimer passes this video off as humor. I consider it to have much more daunting effects. Much of the public is already suspicious of technology and well prepared to believe any news of bad effects, no matter how improbable. The popcorn video is not the first scam that scared people into spending money to protect themselves from RF energy. It was a small sticker that fit under the phone's battery and only cost \$19.95, a small price to pay for to protect your health.

A similar hoax device was advertised around the same time. It was called an "antenna extender" and claimed to be able to boost your cell phone signal so it would work in more locations. Amazingly, it looked identical to the cell phone protection device and was being sold for the same amount. So which is it? Something that decreases the cell phone signal in order to protect you from disease, or something that boosts the cell phone signal? -AR-
