

unique presentation by Mat Nickoson, KC8NZJ. Mat's presentation was titled "Norfolk Southern - Cleveland Terminal". Mat explained how he was hired to become a railroad conductor. The massive trains, some more than two miles long, that move freight around the country are operated by two people, an engineer and a conductor. Mat described the role of the conductor in assembling the train, checking each of the cars, and assisting the engineer in the safe operation of the train. The presentation also included an overview of the Norfolk Southern Railroad operations in the Cleveland area as well as radio technology and frequencies used.

The August meeting was at My Friends Restaurant in Cleveland. We had a special guest presentation on the state of the ARRL and the upcoming elections by **Scott Yonally**, **N8SY**. Scott is currently the ARRL Great Lakes Division Vice Director. Scott is now running for the position of ARRL Division **Director**. 1. Call to Order

The president called the meeting to order at 9:09 a.m.

2. Meeting Minutes

Motion to accept, Marv Grossman, W8AZO. Seconded by Eric Jessen, N8AUC. Motion carried without objection.

3. Treasurer's Report

Provided by Eddie Stevens, KD8FTS. Jeff is still working on transferring PayPal access to Eddie.

4. Membership Report:

Marv Grossman, W8AZO; 138 current.

5. Venue Chair's Report / Discussion:

Eddie, KD8FTS reports the June meeting will be at the Fire House Grille & Pub in Willoughby Hills. We will likely be back at My Friends in October and are planning on Teamz for the November Holiday meeting.

6. Upcoming Programs:

It was suggested that as we had Scott Yonally, N8SY, running for ARRL Division Director at the August meeting, we could hear from the opponent, Michael Kalter, W8CI. Eric Jessen, stated that there is a form to be filled out on Mike's website. Eric had scheduled Marc Barnett, KA8CPB, the Internet of Things (IoT) for September but could move him to October if we can do the October meeting at Fire House. 7. Net Report:

Carl Gedeon, KB8VXE, reported that Mike Coleman, AB8UM and Steve Spisak, K8SAS are back in the rotation. Ed Rivers, W8IE helped with a net. Dave Andrzejewski, AD8G, and Jon Anhold, KM8V volunteered to take a couple of net slots.

8. Sunshine:

Robert Wright, KE8CEO reported that Tom Kopcak, N8ETP (Father of Jeff Kopcak, K8JTK) is reported to be in University Hospital Cardiac center. A card will be sent.

9. Technical Committee Report:

Dave Andrzejewski, AD8G, reported that all repeaters operating. 146.760 suffered a temporary outage due to what appears to be power disturbance at the repeater site. Other repeaters at the site were apparently also affected. 146.760 is still running on Bill Hess's power supply, but Dave has the new power supply for 146.760 and will be getting it installed soon. - LEARA PO Box:

A survey of other nearby post offices shows similar pricing, while some distant rural post offices have cheaper pricing. Commercial PO Box locations such as UPS were even more expensive. Motion by Dave Andrzejewski, AD8G, seconded by Carl Gedeon, KB8VXE, to renew the current PO Box. Motion carried without objection. Marv will take care of renewing our current PO Box.

- 2024 Picnic Food Source:

Bryan Torok, N8OOF raised for future consideration the idea of the LEARA 2024 picnic doing potluck instead of catering. Brian pointed out that the recent multi-club picnic and the NOARS picnic both did potluck. Both were well attended and both had lots of food. After a brief discussion, the matter was tabled to the January Trustees meeting.

ARRL Files Comments Against "Seriously Flawed" HF Rules Petition

ARRL The National Association for Amateur Radio®, as part of its mission to protect Amateur Radio, has filed comments against a proposal that would introduce high-power digital communications to the shortwave spectrum that in many instances is immediately adjacent to the Amateur HF bands.

The "Shortwave Modernization Coalition" (SMC), which represents certain high-frequency stock trading interests, filed the petition with the Federal Communications Commission (FCC). (Previous coverage can be found on ARRL News.) ARRL responded on behalf of its members and the 760,000 licensees of the Amateur Radio Service in the US.

The ARRL Laboratory performed a detailed technical analysis over several months to determine if the proposed rules would affect operations on the bands allocated to Radio Amateurs that are inter-mixed with the Part 90 bands in the spectrum in question.

ARRL's analysis determined that, if the proposed rules are adopted, the new operations inevitably will cause significant harmful interference to many users of adjacent and nearby spectrum, including Amateur Radio licensees. Ed Hare, W1RFI, a 37-year veteran of the ARRL Lab and internationally recognized expert on radio frequency interference, was the principal investigator on the study. Hare concluded the petition should not be granted. "This petition seeks to put 50 kHz wide, 20,000-watt signals immediately next to seven different amateur bands with weaker protections against interference than required in other services," said Hare.

In its formal opposition, ARRL stated, "That destructive interference would result if operations commenced using anything close to the proposed maximum levels."
